# THE CONTEXT FOR CAMPUS POLICIES

#### National Political Debate

- Military-style assault weapons (ban expired 2004)
- Universal background checks (except intra-family gun transfers)
- Ammunition magazine size limits
- Gun trafficking a federal crime
- Armed guards in public schools
- Role of mental health

### Students for Concealed Carry

"...student-run, national, non-partisan organization which advocates for legal concealed carry on college campuses in the United States as an effective means of self-defense."

#### National Rifle Association University (NRA-U)

A two-hour seminar that the NRA will bring to any campus.

"...for college students interested in learning more about NRA, the Second Amendment, gun safety, legislative threats to gun rights and the gun control debate...

[Provides] the tools they'll need to become more effective activists in the fight to protect our freedom, both on and off campus."

Attendees receive hats, tee shirts, stickers, and a free year of NRA membership.

#### State Laws

- Know your state laws on guns and other weapons.
- BAN 21 states ban carrying a concealed weapon on a college campus.
- CAMPUS CHOICE 23 states allow colleges and universities to make their own decisions.
- REQUIRE Utah state law expressly requires public colleges and universities to permit concealed carry.

#### **Court Decisions**

- Know how the state courts have interpreted your state law.
- Concealed carry on campus by court decision in Colorado and Oregon.



- Regents of the University of Colorado v. Students for Concealed Carry, Colo. Supreme Court, March 2012.
   Broad state law on concealed carry divested Board of Regents of authority to adopt contrary rule for public universities.
- Oregon Firearms Educational Foundation v. Board of Higher Education, Oregon Court of Appeals, September 2011. Board had limited places for concealed carry.



## ELEMENTS OF A CAMPUS WEAPONS POLICY

- Statement of Purpose
   Link to educational goals, campus as forum for heated debate
- Definition of Weapon
   Only firearms, other weapons, ammunition?
   Can reference state laws regulating weapons for some definitions



- Persons Covered by Policy
   All employees, students, visitors?
- Exceptions
   Campus public safety officers, ROTC, hunting club, approved instructors of safety programs, law enforcement officers from elsewhere, private security retained by rock band or student being stalked



Policy Substance
 Ban or restrictions
 Process for approving exceptions
 Theatrical productions
 Toys covered or not?
 Any campus signage, e.g., stadium



Locations To Which Policy Applies
 Buildings
 Parking lots
 Branch campuses
 Satellite locations, e.g., agricultural extension offices
 Study abroad



Storage of Weapons
 General requirements
 Campus public safety office
 ROTC
 Residence halls
 Vehicles



Policy Enforcement
 Potential consequences for violating policy
 Procedures for determining policy violation
 Obligation to report suspected violations
 Enforcement against visitors
