DEFENDANT'S ANSWER TO PLAINTIFF'S COMPLAINT and
AFFIRMATIVE DEFENSES

NOW COMES the Defendant, Zachary Felton, by and through his attorney, Gordon M. Bloem, and in answer to the Plaintiff's Complaint states as follows:

1. Neither admits nor denies leaving Plaintiff to his proofs.
2. Admits.
3. Denies as untrue. Plaintiff further alleges that all of Defendant's acts that are at issue
 - a. are speech protected by the 1st and 14th amendments to the United States Constitution and by Article 1, Section 5 of the Michigan Constitution and;
 - b. have resulted in no actionable monetary damage to the Plaintiff.

4. Admits that Plaintiff, Todd Levitt, is a well-known attorney and former fixed term faculty member at Central Michigan University. Defendant further alleges as follows:
 - a. The Plaintiff is a public figure with regard to his practice of law in Isabella County, in particular, as it relates to his representation of Central Michigan University students.
 - b. The Plaintiff is a public figure with regard to his status as a fixed term faculty member at Central Michigan University.
 - c. The Defendant is a 21 year old student at Central Michigan University.
5. Admits.
6. Admits.
7. Defendant admits that a parody Twitter account known as "Todd Levitt 2.0" (hereafter referred to as parody account) did appear at approximately that date. Defendant denies the remaining allegations contained in Paragraph 7 as untrue. Defendant further alleges that:
 - a. All of the Twitter postings in the parody account were caricatures of Twitter postings, YouTube videos, public statements and other publicity stunts engaged in by the Plaintiff and directed, in particular, at the community of Central Michigan University students over a lengthy period of time.
 - b. The parody account started on April 15, 2014 and the last of the 72 tweets was posted on April 29, 2014 when Todd Levitt deleted his own Twitter account.
8. Denies as untrue.
9. Denies as untrue and further alleges that the parody account could not have confused a reasonable reader for reasons which include, but are not limited to, the following:
 - a. It contained a disclaimer identifying it as a parody stating as follows, "A badass (Plaintiff has consistently referred to himself in various public statements as "a badass lawyer") parody of our favorite lawyer most likely seen on Main Street (Exhibit 1)
 - b. On April 22, 2014 the parody account tweeted as follows (Exhibit 2),

" A gentle reminder to potential seekers of Todd Levitt: This is not him. This is a parody account. You can find the real Todd(ler)@levittlaw."

c. On April 16, 2014 the parody account tweeted as follows (Exhibit 3),
"Word of the day for @twebbsays is satire. Three syllables. Once you get a grasp of the concept a lot of things will start making sense."

d. On April 15, 2014 the parody account tweeted (Exhibit 4),

"Remember kiddoes, parody accounts are #badass and #lawful."

10. Defendant admits that he participated in the parody Twitter postings. He denies the remainder of the allegations as untrue.

11. Defendant admits that the parody account referred to itself as "Todd Levitt 2.0 @ Levitt Lawyer". Defendant further admits that he tweeted "My favorite badass movie of all time is 'Catch Me If You Can' @levittlaw." (Exhibit 5). Defendant denies the characterizations made of these tweets in Plaintiff's complaint and further alleges that they were in response to the following tweets that appeared on the Twitter account controlled by Plaintiff on or about April 24, 2014 (Exhibit 6),

"Who did you think you were fucking with? You have no idea who I am #CBA Finance, Law, Grawn computer workers"

"Your own friends and family turned on you you fucks. I have some pissed off clients looking forward to seeing you in prison. Good luck tools"

"If anyone has a class with a CBA finance, law prof today tell them to grab some Vaseline where I'm sending them" (Defendant's father is chair of the Finance and Law Department)

"Anyone see Felton tell him I said I hope his day is going well #CBA"

"@Dr_Houghtaling I'm not saying who. But it's a couple CBA Profs and their dweeb kid who works in Grawn Computers"

"#Felton #Anthony and others. Got you mother fuckers"

"Couple of CMU prof and their loser kid who works in IT hiding behind social media. Punk Ass losers. See you all in court and hell mother fuckers"

"Wonder how the college of business is going to react when they find out a couple Finance Profs and their kid is behind Todd 2.0. #Losers"

"@HawkinsANG011 Couple of loser CBA profs and their IT Grawn working punk kid are hiding behind an account named after me harassing my clients"

"I'm such a bald headed pussy I'm afraid of Todd and his followers. Got you

mother fuckers coming for you."

"@CMLIFE How is the story going to read that CMU professors and their kids run fellow prof/law account. Finance/Law #Felton"

12. Defendant admits that on April 16, 2014, he tweeted "What's the difference between the internet and my tweeted legal advice? A: None. They're both 100% accurate." (Exhibit 7). Defendant denies the remaining allegations in Paragraph 12 as untrue.

13. Defendant admits that on April 16, 2014, he tweeted the following (Exhibit 8),

"Buying me a drink at Cabin karaoke will get you extra credit, but it's not like that matters because you're guaranteed an A in the syllabus."

Defendant denies the remaining portions of the allegations as untrue and further alleges that his tweets took into account the following:

- a. The Plaintiff promised his students he would cancel class if he reached a certain number of Twitter followers.
- b. In six (6) semesters between 2011 and 2013 the Plaintiff has given 277 A's, 8 A-'s, 14 B+'s, 27 B's, 1 B- and no grades lower than the B- and thus the tweet was substantially true or was rhetorical hyperbole.
- c. On February 17, 2014 the Plaintiff tweeted the following (Exhibit 9):

"If classes are not cancelled I'm calling on all my students in my one class I teach to wear winter clothes. We are building a snow fort."

14. Defendant admits that on April 17, 2014, he tweeted the following (Exhibit 10),

"Partying=Defense Clients[,] Defendant Clients=Income[,] If I endorse partying, will my income grow? It's like a Ponzi scheme for lawyers!"

Defendant denies the remaining allegations of Paragraph 14 and further alleges that this tweet was a parody or caricature of the following tweets posted by the Plaintiff (Exhibit 11).

- a. "#Snowday=Old School Toga Party @PoonieFine @bigkev60 @CP_72 Toga, Toga, Toga!!!!!!"

- b. "I would love to go buy a beer from @levittlaw at wayside lol." "@Poonsters You will be able to in a few weeks."
- c. "John Hunter, do students want us bartending at Okelly's or Back bar party at the Wayside? Stoked to serve drinks @Wayside_Okellys"
- d. "Papa John when am I guest bar tending at @Wayside_Okellys? As a former waiter and bartender of 10 years I'm ready to pour some."
- e. "People keep asking me if I am really throwing Todd Levitt's end of the semester rock party. ANSWER: HELL YES. #IWannaRock."

"@oddshapednoggin @Wayside_Central Dominic, no cover bands original music with videos courtesy of Sound Productions, Wayside and yours truly."
- f. "OFFICIAL: just spoke to my dear friend John Hunter from @Wayside_Okellys the party is on. Tentative date April on a Wed night. #TMFM"
- g. "ANNOUNCEMENT: I just decided to throw an end of semester rock party. I'll be picking out the music. Location to be announced @Wayside_Central"
- h. "If I could get my hands on one of those t-shirt cannons I would shoot cans of Bud up into the student section."

15. Defendant admits that on April 20, 2014, he tweeted the following (Exhibit 12),

"@twebbsays should either meet with me at 4:20 in my satellite office or take a hiatus from the medical card."

"#inToddWeToke" and "4/20=Pot smoking holiday[.] Possessoion of marijuana=Client[.] Client=Income[.] In the words of Snoop Dogg: smoke weed every day. #inToddWeToke"

Defendant denies the remaining portions of Paragraph 15 as untrue and further alleges that these tweets were a caricature or parody of the following posted by Plaintiff,

"Walt Jr needs to smoke a blunt a chill out!!!"

"If marijuana was legalized in Mt Pleasant the dorms would look like they were on fire #ImJustSaying" (Exhibit 13)

16. Defendant admits that the Plaintiff has deleted his Twitter account and thus destroyed evidence material to the claims he brings in this case.

17. Defendant neither admits nor denies and leaves the Plaintiff to his proofs.

18. Defendant neither admits nor denies and leaves the Plaintiff to his proofs.

19. Denies as untrue and further alleges that Plaintiff had declined to continue his teaching at Central Michigan University prior to the onset of the parody account (Exhibit 14).

20. Denies as untrue.

23. Denies as untrue. Defendant further alleges that all of his tweets were constitutionally protected as parody or caricature, were truthful, or in the nature of rhetorical hyperbole.

AFFIRMATIVE DEFENSES

Defendant asserts the following Affirmative Defenses to the various claims filed by the Plaintiff.

UNCLEAN HANDS

Plaintiff's request for equitable relief fails as he comes to the court with unclean hands for reasons which include, but are not limited to, the following:

1. Plaintiff has destroyed evidence material to his claim by deleting his entire Twitter account. Since Defendant's parody account was a caricature of the various postings on that account, the Plaintiff, an attorney, has destroyed evidence prior to the filing of this claim.
2. The Plaintiff has engaged in intimidating behavior to various individuals who are potential witnesses to the facts and circumstances of this case.
3. Plaintiff has behaved in a manner generally inconsistent with the Michigan Code of Professional Conduct by engaging in the following non-inclusive list of activities:
 - a. Creating a fake award "College Lawyer of the Year" for himself and using this "award" to promote himself (Exhibit 15) in violation of MPRC 7.1 which prohibits a lawyer from making false misleading or deceptive statements.
 - b. The Plaintiff tweeted the following statement,

"A good lawyer knows the law. A #BadAssLawyer gets the judge elected. #ToddLevitt" (Exhibit 16)
4. In the Verified Complaint Plaintiff has misstated a material fact by implying that he lost his status as a fixed term faculty member at Central Michigan University because of the parody Twitter account. In fact, he had already informed his department chair that he was not interested in teaching at Central Michigan University any longer prior to the parody account being started.

PUBLIC FIGURE

5. For purposes of his claims Defendant is a public figure and therefore the parody Twitter account is speech protected by the 1st and 14th amendments to the United States Constitution and by Article 1 Section 5 of the Michigan Constitution.

TRUTH/OPINION/RHETORICAL HYPERBOLE

6. All of the posts contained in the parody account are either true, opinions, or in the form of rhetorical hyperbole and are therefore protected speech under the 1st and 14th amendments to the United States Constitution and by Article 1 Section 5 of the Michigan Constitution.

WHEREFORE, Defendant requests that the Court:

1st Strike the jury demand as the only relief Plaintiff requests is an injunction, an equitable remedy, to which the right to a jury trial does not attach.

2nd Dismiss the complaint with prejudice and will full costs of the litigation awarded to the Defendant.

3rd Grant such other and further relief as shall be agreeable to equity and good conscience.

We measure Influence by assessing how frequently you are Retweeted, Replied, Mentioned and Followed on Twitter, Facebook, Vine, Youtube and all forms of social media. If you connect with the students thru these channels and influence them in a positive way. Interactions count towards your influence which include Posts, Mentions, Likes, Shares and Event Invitations.

- **Generosity**

We measure generosity through the level of student engagement volunteering your time to guide and assist them with both their legal issues and careers.

- **Pro Bono**

Pro bono is a Latin phrase for professional work undertaken voluntarily and without payment or at a reduced fee as a public service.

- **Education**

Education in its general sense is a form of learning in which the knowledge, skills, and habits of a group of people are transferred from one generation to the next through teaching, training, or research. Any experience that has a formative effect on the way student thinks, feels, or acts may be considered educational. We measure education in the form of full or part time faculty in

addition to other factors.

- **Volunteering**

Volunteering is intended to promote good or improve student quality of life. This activity produces a feeling of self-worth and respect in the student body. There must not be a financial gain. We measure the persons involvement with student organizations, sponsorship of student events, charitable work and leadership positions that influence the student body.
